# **EMPLOYMENT INSURANCE (EI) UPDATE**



#### 2025 MAXIMUM INSURABLE EARNINGS

Effective January 1, 2025 the maximum insurable earnings is increasing from \$63,200 to \$65,700. This means the Employment Insurance (EI) weekly maximum benefits will also be increasing from \$668 to \$695.

If your benefit plan has Short Term Disability (STD)/Weekly Indemnity (WI) and you receive a reduced El premium rate due to this, to comply with the provision of your policy the maximum benefit must at least equal the new El maximum of \$695 for 2025.

If your STD/WI plan has a maximum that is higher than \$695, no change is required. If you have more than one benefit class of employees with STD/WI coverage each benefit class will need to meet these standards.

Only employees who are insured for the STD/WI benefit are eligible for the reduced EI premium rate. All other employees are still deducted the full EI premium rate.



#### **DID YOU KNOW?**

If your plan has Short Term Disability/Weekly Indemnity benefits you may qualify for an El premium rate reduction. Ask us for more information!

# Canada Post Strike

As most of us are aware, Canada Post workers went on strike November 14, 2024. We wanted to take this opportunity to provide a friendly reminder that all insurance carries have alternate means for submitting benefit claims and receiving benefit payments that do not include postal services.

Providers offer plan members options such as Mobile Apps, Websites, and Direct Deposit for submitting benefit claims and receiving payments. Digital options have been the preferred method for carriers for a long time, however it is most important now to utilize these options to avoid delay on processing times and receiving payments.
